## 5. LEVERAGE AND MARGIN

5.1 Investing and operating with us enables you to use leverage to open a Contract by depositing a fraction of the total Contract value. This means that a relatively small market movement may lead to a proportionately much larger movement in the value of your Contract. You can trade Margin Contracts and other CFDs and Options contracts with a high degree of leverage because of the small Margin requirements. Trading with leverage means that even a slight change in the market could lead to a proportionately much larger movement in the value of your investment.

5.2 You should note that any changes that you make to your leverage level on an already traded Account can immediately affect your open positions, and we may require you to provide additional funding to support your open Contracts.

5.3 If you're a Retail Client or Institutional and your equity (Account balance plus running profit/loss) falls below the 50% Margin level required to maintain your open Contracts, we will automatically close them.

5.4 If you're a Professional Client and your equity (Account balance plus running profit/loss) falls below the Margin required to maintain your open Contracts, we'll automatically close them when your Margin reaches the following thresholds:

5.5 It's your responsibility to monitor the required Margin for your open Contracts and in order to avoid a stop-out you may have to fund your Account. You can monitor your Contracts (and Margin requirements) on your Platform.

## 6. SERVICES MANAGEMENT

We reserve the right, but not the obligation, to: (1) monitor the Services for violations of these Legal Terms; (2) take appropriate legal action against anyone who, in our sole discretion, violates the law or these Legal Terms, including without limitation, reporting such user to law enforcement authorities; (3) in our sole discretion and without limitation, refuse, restrict access to, limit the availability of, or disable (to the extent technologically feasible) any of your Contributions or any portion thereof; (4) in our sole discretion and without limitation, notice, or liability, to remove from the Services or otherwise disable all files and content that are excessive in size or are in any way burdensome to our systems; and (5) otherwise manage the Services in a manner designed to protect our rights and property and to facilitate the proper functioning of the Services. All accounts are required to stay in the market for at least 12 months. The company charges no commissions upfront and only takes a 10% commission on your margin gain if you achieve a 30% or more profit.

**6.1 Retail Account:** These accounts are designed for individuals seeking short-term interaction on a quarterly basis. Retail accounts earn a lower percentage due to a 12-month minimum holding period before liquidation. However, profits can be withdrawn after 6 months. After the minimum term, account holders can access 70% of their capital, with a 30% operational minimum. Inactive accounts for 10 business days incur a 5% daily fee on total equity.

**6.2 Institutional Account:** Institutional accounts are designed for long-term growth and stability, targeting individuals seeking high returns over time. The minimum starting amount is \$100,000 USD. These accounts focus on diversification and require a minimum commitment of three years. Initial returns become available after 12 months. Withdrawals can be made above the profit margin, and after 18 months, account holders can access 70% of the portfolio, with a 30% operational minimum. Inactive institutional accounts incur a 3% daily fee on total equity after 10 business days.



## 7. PRIVACY POLICY

We respect the intellectual property rights of others. 8.2 If you terminate your account before 6 months, a penalty fee of 30% of your equity will apply, along with any commissions and fees from trades. Typically, closing an account before meeting the minimum requirements takes around 90 days.

We reserve the right to change, modify, or remove the contents of the Services at any time or for any reason at our sole discretion without notice. However, we have no obligation to update any information on our Services. We will not be liable to you or any third party for any modification, price change, suspension, or discontinuance of the Services.

Lerner Pratt LTD and yourself both agree to submit to the non-exclusive jurisdiction of the courts of London, which means that you may make a claim to defend your consumer protection rights regarding these Legal Terms in the United Kingdom, or in the EU country in which you reside.

## 11. DISPUTE RESOLUTION

### Informal Negotiations

To expedite resolution and control the cost of any dispute, controversy, or claim related to these Legal Terms (each a "Dispute" and collectively, the "Disputes") brought by either you or us (individually, a "Party" and collectively, the "Parties"), the Parties agree to first attempt to negotiate any Dispute (except those Disputes expressly provided below) informally for at least thirty (30) days before initiating arbitration. Such informal negotiations commence upon written notice from one Party to the other Party.

### Binding Arbitration

Any dispute arising from the relationships between the Parties to these Legal Terms shall be determined by one arbitrator who will be chosen in accordance with the Arbitration and Internal Rules of the European Court of Arbitration being part of the European Centre of Arbitration having its seat in Strasbourg, and which are in force at the time the application for arbitration is filed, and of which adoption of this clause constitutes acceptance. The seat of arbitration shall be London, United Kingdom. The language of the proceedings shall be English. Applicable rules of substantive law shall be the law of the United Kingdom.

### Restrictions

The Parties agree that any arbitration shall be limited to the Dispute between the Parties individually. To the full extent permitted by law, (a) no arbitration shall be joined with any other proceeding; (b) there is no right or authority for any Dispute to be arbitrated on a class-action basis or to utilize class action procedures; and (c) there is no right or authority for any Dispute to be brought in a purported representative capacity on behalf of the general public or any other persons.

### Exceptions to Informal Negotiations and Arbitration

The Parties agree that the following Disputes are not subject to the above provisions concerning informal negotiations binding arbitration: (a) any Disputes seeking to enforce or protect, or concerning the validity of, any of the intellectual property rights of a Party; (b) any Dispute related to, or arising from, allegations of theft, piracy, invasion of privacy, or unauthorized use; and (c) any claim for injunctive relief. If this provision is found to be illegal or unenforceable, then neither Party will elect to arbitrate any Dispute falling within that portion of this provision found to be illegal or unenforceable and such Dispute shall be decided by a court of competent jurisdiction within the courts listed for jurisdiction above, and the Parties agree to submit to the personal jurisdiction of that court.

## 15. INDEMNIFICATION
